Hearing on the request of Brien Vierra, agent for Phillips 66 Pipeline, LLC (Phillips 66), to consider Case No. 15DVP-00000-00004, [application filed on April 6, 2015], for approval of a Development Plan in compliance with Section 35.82.080 of the County Land Use and Development Code, on property zoned AG-II-100, to construct and operate a 1.2-mile long, 6-inch diameter, buried crude oil pipeline within an existing pipeline corridor; and to determine the project is exempt from the provisions of the California Environmental Quality Act (CEQA) pursuant to State CEQA Guidelines Section 21080.23.
