Exempt, CEQA Section 15061(b)(3) Allen Bell, Planner (805) 568-2033

Hearing on the request of Stephen Larralde, owner, to consider Case No. 06RZN-00000-00003 [application filed on April 4, 2006] proposing to rezone 21.71 acres from 100-AG under Ordinance No. 661 to AG-II-100 under the provisions of Santa Barbara County Code Chapter 35 of Article III; and to accept the Exemption pursuant to Section 15061(b)(3) of the State Guidelines for Implementation of the California Environmental Quality Act. The application involves AP No. 081-040-028, Goleta area, Third Supervisorial District.

Hearing on the request of Jeff Nelson, agent for the owners, Larry and Jackie Cavaletto to consider the following [application filed on December 31, 2001 and resubmitted on August, 1, 2005]:

a) **01GPA-00000-00009** proposing to initiate an amendment to the Santa Barbara County Comprehensive Plan Land Use Element and Goleta Community Plan by changing the Land Use Designation from A-1 to residential (zone district to be determined) under Article III; and

b) **01RZN-00000-00015** proposing to rezone 25.9 acres from AG-I-5 to Residential (zone district to be determined), 8 units per acre under the provisions of Santa Barbara County Code Chapter 35 of Article III.

The applicant involves AP Nos. 069-100-006, -051 and -057, located at 560 Merida Drive, Goleta area, Second Supervisorial District.

**ACTION: Recommended that the Board of Supervisors initiate an amendment to the Goleta Community Plan Land Use Map, included in the Comprehensive Plan, to a density consistent with the project (i.e. average 6.6 du/ac).**

3. **06ORD-00000-00007**      **Articles II/III General Height**  
**06ORD-00000-00008**      **Regulations Ordinance Amendment**      **Countywide**

Hearing on request of Planning and Development Department to consider Case Nos. 06ORD-00000-00007 and 06ORD-00000-00008 proposing amendments to the Coastal and Inland Zoning Ordinances (Articles II and III, respectively, of Chapter 35 of the Santa Barbara County Code). These proposed amendments would exempt certain types of equipment from the maximum height restriction of 50 feet established in Sections 35-127.1 and 35-276.1. Exempt equipment would include temporary oil/gas drilling rigs, stripper and distillation columns with gas processing and ethanol manufacturing, flare stacks, industrial storage silos, commercial wind turbines for generating electricity, and industrial structures associated with the Celite Corp. operations in the Lompoc area, Third Supervisorial District.
