Hearing on the request of Planning & Development, Parks, and General Services Departments, to consider case no. 11GOV-00000-00015, application filed on November 18, 2011, for a determination that the proposed acquisition by dedication to the County of 1) 306 acres of open space in fee, and 2) public trail easements – all within the boundaries of the Rice Ranch Specific Plan (Orcutt Community Plan Key Site 12) – is consistent with the Comprehensive Plan of the County of Santa Barbara pursuant to Government Code §65402(c). The site is identified as Assessor Parcel Numbers 101-380-001, -002, and -003; 101-390-001; and 101-400-001, -002, and -003, located south of Rice Ranch Road, in the Orcutt area, Fourth Supervisorial District.

Hearing on the request of Jeff Nelson to consider Case No. 10TRM-00000-00001, [application filed on May 4, 2010] for approval of a Vesting Tentative Tract Map in compliance with County Code Chapter 21 to divide 14.87 acres into 18 lots of varying sizes, including 16 residential lots, on property zoned 1-E-1; and to adopt the Negative Declaration (11NGD-00000-00013) pursuant to the State Guidelines for Implementation of the California Environmental Quality Act. As a result of this project, significant but mitigable effects on the environment are anticipated in the following categories: Aesthetics, Air Quality, Biological Resources, Cultural Resources, Fire Protection, Geologic Processes, Land Use, Noise, Public Facilities, Transportation, and Water Resources.
