Fernald Point Lane Bridge and 18TEX-00000-00005 Fish Passage time Extension Project

The proposed project would allow for a one year time extension to March 18, 2019 (one year from the March 18, 2018 expiration date) for the Fernald Point Lane Bridge and Fish Passage project (Case No. 15CDH-00000-00035). A time extension is being requested due to the local emergency caused by the January 9th, 2018 debris flow in Montecito and the unavailability of Public Works staff to work on the project. The project is primarily located in the public rightof-way on Fernald Point Lane spanning Romero Creek, with components of bridge replacement and habitat restoration also located on portions of APNs 007-380-024 and -004, in the Montecito Community Plan area, First Supervisorial District.
